remind everyone that overfilling the dumpsters costs extra and we ask that you break items down and recycle cardboard boxes instead of



putting them in the dumpster. These items cannot be placed in dumpsters:

- Appliances (all white goods)
- Buckets with paint, solvents, etc.
- Computer monitors or other computer components •
- Drums and containers •
- Electrical equipment containing hazardous material
- Friable asbestos .
- Hazardous Waste
- Lawnmowers with oil and gas
- Liquid Waste .
- Outdoor grills with propane tank •
- Paint cans
- Propane tanks (all sizes)
- Spray paint cans or containers
- Tires (whole, cut, or baled)
- TV's, VCR's, stereos or similar electronic waste
